## What is this product?

**Type:** This is a closed-ended investment company incorporated in the UK and whose ordinary shares are admitted to trading on the Alternative Investment Market (AIM) of the London Stock Exchange in the UK.

**Objectives:** Urban Logistics REIT plc (The Company) aims to deliver investment returns through income, with regular dividends providing Shareholders with a sustainable income stream that will grow over the medium term, and capital growth. To achieve its investment objective, the Company invests in a diversified portfolio of primary and secondary grade logistics properties (freehold or leasehold) within the UK. The Company may acquire properties directly or through holdings in special purpose vehicles or through limited partnerships, trusts or other vehicles with third party co-investors.

**Intended retail investor:** Individuals who are professionally advised or highly knowledgeable, who understand and are capable of evaluating, the risks and merits of an investment in the Company and who have sufficient resources to be able to bear any losses, which may be equal to the whole amount invested, resulting from an investment in the Company.

**Maturity:** There is no maturity date.

	 <p>This risk indicator assumes you keep the product for 5 years which is the recommended holding period. ## How long should I hold it and can I take money out early?

**Recommended holding period: 5 years**
